

### ARTICLES OF INCORPORATION

### ARTICLE I. NAME

The name of the corporation shall be 6320 Trail Inc.

### ARTICLE II. DURATION

This corporation shall exist perpetually.

## ARTICLE III. PURPOSE

In the absence of fraud, no contract or other transaction between this corporation and any other corporation or any individual or firm shall be in any way affected or invalidated by the fact that any of the Directors or Officers of this corporation are interested in such contract or transaction, provided that such interest shall be fully disclosed or otherwise known to the Board of Directors in the meeting of such Board at which meeting such contract or transaction is authorized or confirmed, and provided, however, that any such Directors of this corporation who are so interested may be counted in determining the existence of a quorum at any meeting of the Board of Directors of this corporation which shall authorize or confirm such contract or transaction, and any such Director

may vote thereon to authorize any such contract or transaction with like force and effect as if such Director were not a Director or Officer of the other corporation or not so interested.

# ARTICLE XII. REPLACING STOCK CERTIFICATES
