## ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION O

## ARTICLES OF INCORPORATION OF APPLIED PROGRAMMING SOLUTIONS, INC.

Pursuant to the provisions of Section 607.1006, Florida Statutes, this Corporation adopts the following Articles of Amendment to its Articles of Incorporation by stating the following:

FIRST: The present name of the Corporation is Applied Programming Solutions, Inc..

SECOND: The following amendment to its Articles of Incorporation was adopted:

1. Article IV is amended and restated as follows:

## "ARTICLE IV CAPITAL STOCK

This corporation is authorized to issue 50,000,000 shares of common stock.

The common stock of the corporation shall have the following characteristics:

- (a) Par value shall be \$0.01 per share.
- (b) At all meetings of the stockholders, the common stockholders shall be entitled to cast one (1) vote for each share of common stock owned. That a common stockholder is interested in a matter to be voted upon shall not disqualify him from voting thereon.
- (c) Except as otherwise provided by law, the entire voting power for the election of the directors and for all other purposes shall be vested exclusively in the holders of the outstanding common stock."

THIRD: The date of the amendment's adoption is March 29, 2000.

FOURTH: The foregoing amendment was adopted by the directors and shareholders of the Corporation, and the number of votes cast for the amendment were sufficient for approval.
