ARTICLES OF INCORPORATION

OF

D. C. BUSINESS CO.

We, the undersigned, all of whom of legal age, do hereby associate ourselves for the purpose of becoming a corporation under the laws of the State of Florida authorizing the formation of Corporations.

ARTICLE I - NAME

The name of this corporation shall be:

- d) To contract debts and borrow money, issue and sell or pledge bonds, debentures, notes and other evidences of indebtedness, and execute such mortgage, transfer of corporate indebtedness as required.

- e) To purchase the corporate assets of any other corporations and engage in the same or other character of business.
- f) To acquire by purchase, subscriptions or otherwise and to receive, hold, own, guarantee, sell, assign, exchange, underwrite, transfer, mortgage, pledge or otherwise dispose of or deal in and with any of shares of the Capital Stocks of any voting trust, certificates in respect or the shares of Capital Stocks, warrants, rights, binds, debentures, notes, and other securities, obligations, chose in action and evidence of indebtedness or interest issued or created by any Corporation, joint stock companies, syndicates, associations, firms, trsusts, or persons; public or private, or by the government of the United States of America, or by any foreign government, or by State, territory, province, minicipality or other political subdivision of by any government agency, and as owner thereof, to possess and excersise all of the rights, powers and privileges of ownership, including the rights of execute consents and rights to vote thereon, and do any and all acts and things necessary or advisable for the prevention; improvement, and enhancement in value thereof.
