



Please accept this filing for the 2000 Uniform Business Report. Since this company operates in the state of Florida and is managed in the state of Nebraska confusion arose over the responsibility of filing this return.

The management in the state of Nebraska assumed that all filings were to be made by the registered agent, who is located in the state of Florida. The operations, which is located in the state of Florida does not have the authority to file this form. Through conversions with the management, the registered agent, and operations there was no knowledge or receipt of the 2000 Uniform Business Report. Accordingly, it was not filed on a timely basis.

We did file on a timely basis a Florida Franchise Tax Return. We would also like to add that this is the first year that this corporation has done business in the state of Florida. We have put into place procedures that will prevent this from happening in the future. We think looking at all of the circumstances, our client did not act in a reckless manner nor was there a disregard for the proper filings for the state of Florida.

We are asking for the reinstatement of this corporation and the acceptance of the \$150.00 as originally due. We feel that since this corporation is still considered a start up business any additional tax would be an undue hardship on this corporation.
