
The management in the state of Nebraska assumed that all filings were to be made by the registered agent, who is located in the state of Florida. The operations, which is located in the state of Florida does not have the authority to file this form. Through conversions with the management, the registered agent, and operations there was no knowledge or receipt of the 2000 Uniform Business Report. Accordingly, it was not filed on a timely basis.

We did file on a timely basis a Florida Franchise Tax Return. We would also like to add that this is the first year that this corporation has done business in the state of Florida.
