ARTICLES OF INCORPORATION

OF

SALTEL, INC.

The undersigned, being of full age and for the purpose of forming a corporation surder Florida 1989 Business Corporation Act, does hereby adopt the following Articles of Incorporation:

ARTICLE I

Name

The name of this corporation shall be SALTEL, Inc.

ARTICLE II

Registered Office and Agent

The location and address of this corporation's registered office in this state shall be 1200 South Pine Island Road, Plantation, Florida 33324. The corporation's registered agent at that address is CT Corporation System.
