Pursuant to the provisions of 607.1006, Florida Statutes, this Florida profit corporation adopts the following Articles of Amendment to its Articles of Incorporation.

The name of corporation today is Miami-Dade Medical Assistance, Inc., and the corporation was formed in the State of Florida on January 15, 1999


1. On July 24, 2002, stockholders holding a majority of the voting power of the corporation, by written consent pursuant to 607.0704 adopted the recommendation of the Board of Directors and amended Article 1 of the Articles of Incorporation. The number of votes cast for this amendment sufficient for approval.
2. As of July 24, 2002, Article 1, as amended, shall read as follows:


ARTICLE I

The name of this corporation shall be changed from Miami-Dade Medical Assistance, Inc. to:

GLOBAL HORIZON INVESTMENTS, INC.

This amendment was adopted by the board of directors without shareholder action, as allowed by section 607.1002 of the Florida Business Corporation Act.
