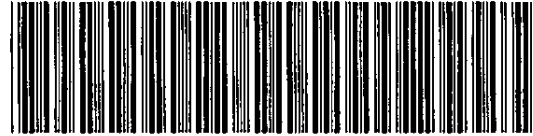



SECOND: Amendments adopted:


ARTICLE I - NAME
