
Enclosed please find a check for the \$150.00 filing fee for the above named corporation. I will try to explain what has happened with Mr. Estes, and his corporation, Lake Weir Auto Sales, Inc., since we became his bookkeepers.

Mr. Estes sold his business at the end of 2002, therefore he was not going to renew his license, so he did not submit his filing fee right away. However, in April, Mr. Estes had to return to Bellevue, and take back his business from the person he sold it to for failure to make the payments. We then called your division, and spoke to Deidre on April 24th, and told her that Mr. Estes needed to make his corporation active, and pay his \$150.00 filing fee, but he did not receive any papers to do so. She told us to copy the old filing form and send it in with the check, which Mr. Estes did.

Mr. Estes then realized that his former wife's name was on the corporation, and he wanted to remove all of the former officers except him. We called your office once again on June 16th and spoke to Mario, and appraised him of the problem. He told us that he would send us a blank report form that we could fill out and change the names. We filled that form out and sent it in to you on June 23, 2003. We just received that form back, and a request for a check for filing the annual report of \$550.00. When we received this back, we started looking for the cancelled check, that was mailed originally on April 24th, 2003, well before the late filing fee date of May 1st, 2003, and could not find that it had come back from the bank cashed. We are therefore asking that you accept the enclosed check, and waive the late penalty filing fee as we believed it was paid earlier. Mr. Estes has been trying to clean up the mess made by the person that he sold the business to, but it is taking time. He is trying to do his best to get all of his paperwork in order.
