The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporations Act, hereby adopts the following Articles of Incorporation.

**ARTICLE ONE  
NAME**

The name of the Corporation shall be Sunshine Lawn Care, Inc.

**ARTICLE TWO  
REGISTERED OFFICE AND AGENT**

The location and address of the Corporation's initial registered office in Florida is 167 Bermuda Road, Marco Island, Collier County, Florida, 34145. The initial registered agent at the registered office is Salvatore Iannotta who upon accepting this designation agrees to comply with the provisions of Florida Statutes, as amended from time to time, with respect to keeping an office open for service of process. No shareholder, notwithstanding that he or she may have voted against the amendment or may have objected in writing, shall be entitled to payment of the fair cash value of his or her shares or any right of a dissenting shareholder.
