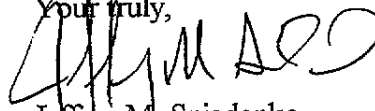

The undersigned, for the purposes of forming a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation:

**ARTICLE I  
NAME**

The name of the corporation is Glass & Mirror Shop, Inc.

**ARTICLE II  
ADDRESS OF PRINCIPAL OFFICE/  
MAILING ADDRESS OF CORPORATION**

AUTHORIZED SHARES**
