**ARTICLES OF INCORPORATION
OF
AMABLE FINANCE SAVINGS CORP**

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation.

ARTICLE I: NAME

The name of the Corporation is: **AMABLE FINANCE SAVINGS CORP**

ARTICLE II: DURATION

The existence of the Corporation shall commence with the filing of these Articles. The duration of the Corporation is perpetual.

ARTICLE III: PURPOSE

The Corporation may engage in any activity or business permitted under the laws of the United States and under the laws of the State of Florida.

ARTICLE IV: CAPITAL STOCK

The total number of shares of capital stock authorized to be issued by the Corporation will be one hundred (100) shares having par value of one dollar (\$1.00) per share. Each of the shares of stock will entitle the holder thereof to one (1) vote at any meeting of the stockholders.

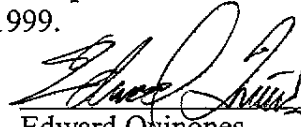
ARTICLE VIII: INCORPORATOR

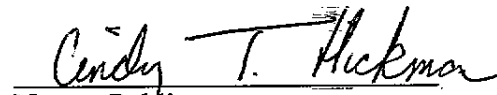

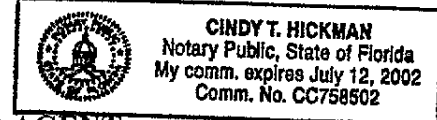
