**ARTICLES OF INCORPORATION
OF
TAMPA BAY OFFICE MOVER'S INC.**

The undersigned files these articles for the purpose of forming a corporation under Chapter 607, Florida Statutes, 1983, and certifies as follows:

ARTICLE I

The name of the corporation shall be Tampa Bay Office Mover's, Inc.

ARTICLE II

The purpose for which the corporation is organized is to transact any and all legal businesses for corporations to be engaged in pursuant to Chapter 607, Florida Statutes, 1983. The corporation's existence shall be perpetual.

ARTICLE III

The corporation shall have the authority to issue five hundred (500) shares of common stock with a par value of One Dollar (\$1.00) per share. There shall be only one class of stock and no share of stock shall have any preference over any other share of stock.

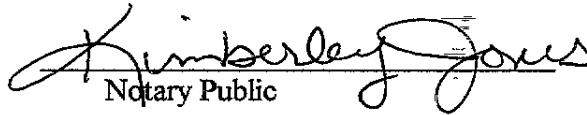

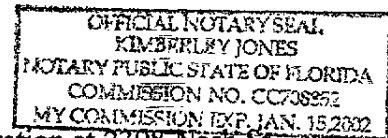
