ARTICLES OF INCORPORATION

OF

ARTICLE I

CORPORATE NAME

The name of the corporation shall be

U.C.R. Inc.

ARTICLE II

DURATION

The corporation shall have perpetual existence, unless sooner dissolved according to law.

ARTICLE III

NATURE OF BUSINESS

The general nature of the business to be transacted shall be the development of
Ultimate Carpet Restoration and services related to carpets cleaning,
and all related manners of business, as well as any other business or activities permitted
