ARTICLES OF INCORPORATION

ARTICLE I. NAME. The name of the corporation shall be LORIA ENTERPRISES, INC.

ARTICLE II. DURATION. The corporation shall exist perpetually.

ARTICLE III. PURPOSE. The purpose of this corporation is for real estate transactions and hair designs and for the transaction of any lawful business for which corporations may be incorporated under the law of the State of Florida.
