The undersigned does hereby subscribe to, acknowledge and files the following Articles of Incorporation for the purpose of creating a corporation under the laws of the State of Florida.

ARTICLE I - NAME

The name of this corporation is INTERCARGO TRANSPORT & LOGISTICS, INC.

ARTICLE II - PURPOSE

This corporation is organized for the purpose of transacting any and all lawful business permitted under the laws of Florida, including, but not limited to, Import/Export, Non-vessel Operating Common Carrier (NVOCC), Vessel Operating Common Carrier (VOCC), and Freight Forwarder.
