The name of the corporation is AERIX.COM, INC.

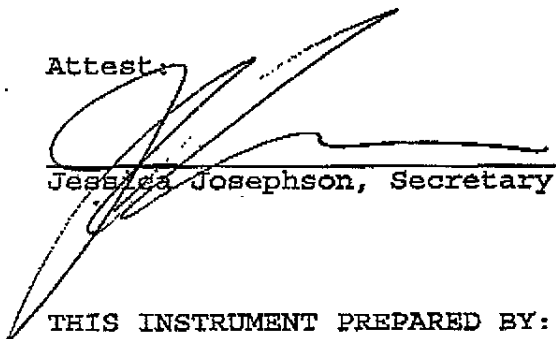
