ARTICLES OF INCORPORATION OF ABDALLAH FOOD MARKET, INC.

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, do hereby adopt the following Articles of Incorporation:

ARTICLE 1. NAME. The name of the corporation is: **ABDALLAH FOOD MARKET, INC.**
