The name of this corporation shall be AAA Electric Sign & Supply, Inc.

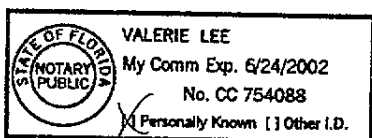


