#### ARTICLES OF INCORPORATION

OF

# **CSC ASSOCIATED ENTERPRISES, INC.**

I, the undersigned Incorporator and Subscriber, being a natural person simple to contract, hereby organize and incorporate under the laws of the State of Florida a corporation for profit as follows:

#### **ARTICLE I - NAME OF CORPORATION**

The name of this Corporation shall be CSC ASSOCIATED ENTERPRISES, INC., having as its initial corporate mailing address: 6043 Kimberley Blvd., Suite M., North Lauderdale, FL 33068.

#### **ARTICLE II - DURATION**
