**ARTICLES OF INCORPORATION

ARTICLE I - NAME

The name of this Corporation is Parkland Development Corp. V.

ARTICLE II - DURATION

This Corporation shall have perpetual existence commencing upon filing of these Articles.

ARTICLE III - BUSINESS AND PURPOSE

This Corporation is organized for the following purposes:

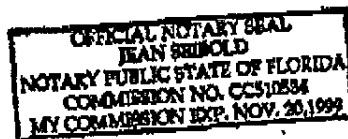
