# ARTICLES OF INCORPORATION

#### ARTICLE I - NAME

The name of the corporation is Inter Call Net Service, Inc. (the "Corporation").

#### **ARTICLE II - PURPOSE**

The Corporation is organized to transact any and all lawful business for which corporations may be incorporated under the Florida Business Corporation Act.

#### ARTICLE III - CAPITAL STOCK

The maximum number of shares the Corporation shall have the authority to issue is 7,500, all of which shall be Common Shares. The par value of each Common Share will be \$1.00.
