THE FOLLOWING ARTICLES OF INCORPORATION:

ARTICLE 1
NAME

ARTICLE 2
TERM OF EXISTENCE

THIS CORPORATION IS TO EXIST PERPETUALLY.

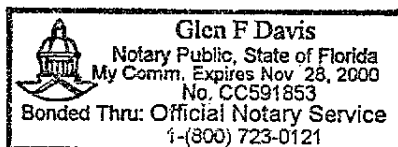
