The undersigned, acting as incorporator of a Florida Corporation under the *Florida General Corporation Act, Chapter 607, Florida Statutes*, adopts the following Articles of Incorporation for such corporation:

ARTICLE I. NAME

The name of the corporation is **RICHARD C. SINGER, P.A.**

ARTICLE II. DURATION

The corporation shall have perpetual existence commencing on the date of subscription and acknowledgement of these Articles of Incorporation.

ARTICLE III. PURPOSE

The corporation is organized for the purpose of the practice of law and for transacting any and all lawful business for which corporations may be incorporated in the State of Florida.

ARTICLE IV. CAPITAL STOCK

The corporation is authorized to issue 1,000 shares of One Dollar (\$1.00) par value common stock.

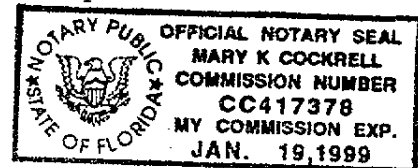
