



ARTICLES OF INCORPORATION OF SPECTRUM WOOD FLOORS, INC.



ARTICLE I. NAME AND ADDRESS: The name of the Corporation is SPECTRUM WOOD FLOORS, INC., and it's principal office and mailing address is 2345 NE 209 Street, North Miami Beach, Florida 33180.

ARTICLE II. REGISTERED AGENT AND ADDRESS: The Registered Agent is MEIR ISRAEL, and the initial registered office of the Corporation is 2345 NE 209 Street, North Miami Beach, Florida 33180.


