Dear Mr. Toner:

There was no delivery of the UBR's for the above corporations, due to destruction to flooding. Per conversation today, application is made for relief from the reinstatement penalties, because of physical damage to the property where the UBR's for the above corporations were apparently mailed. As indicated in my letter to your office of 10/5/01, my office was under construction for the 7 months prior to October 2001, or about March/April 2001, at 1401 South Andrews Avenue, Ft. Lauderdale. The mail was delivered at 1411 South Andrews, in a connecting but different building, which in turn suffered a severe roof leak with flooding, causing damage to files and mail in this temporary office. Apparently the UBRs were destroyed at that time, despite me looking everywhere for them, so there effectively was no delivery to me to file the forms.

Kindly consider this hardship request so that the corporations can be reinstated at this time.
