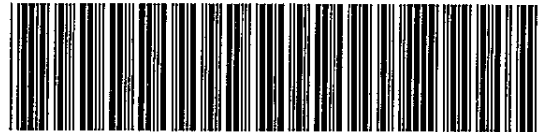

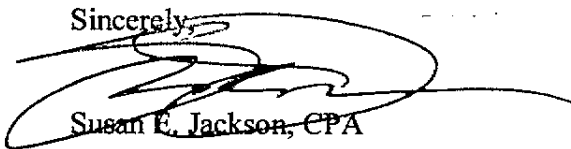
To Whom It May Concern:

**ARTICLES OF AMENDMENT TO
ARTICLES OF INCORPORATION OF
CIBERLYNX, INC.**

1. The name of the Corporation is CiberLynx, Inc. (d/b/a "WebUnited").
2. The Articles of Incorporation of the Corporation are hereby amended by deleting Article THIRD thereof in its entirety and by substituting in lieu thereof the following new Article THIRD:
 - a. "THIRD: The aggregate number of shares which the Corporation shall have authority to issue is 150,000,000, all of which are of a par value of \$ 0.00001 each and are of the same class and are to be common shares."
3. The aforesaid Amendment was adopted on December 31, 2002, pursuant to a written statement and consent to corporate action executed by all of the shareholders and directors of the Corporation in which the number of votes in favor of the amendment was sufficient for approval.

IN WITNESS WHEREOF, the Corporation, by the undersigned, has executed these Articles of Amendment to the Articles of Incorporation on this 31st day of December, 2002.
