ARTICLES OF AMENDMENT TO
ARTICLES OF INCORPORATION OF
JR STUART LAND CORP.

1. The name of the Corporation is JR Stuart Land Corp.
2. The Articles of Incorporation of the Corporation are hereby amended by deleting Articles FIRST and THIRD thereof in their entirety and by substituting in lieu thereof the following new Articles FIRST and THIRD:

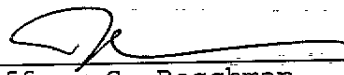
"FIRST: The name of the corporation (hereinafter called the "Corporation") is RG Reserve, Inc."

"THIRD: The aggregate number of shares which the Corporation shall have authority to issue is 5,000, all of which are of a par value of \$0.01 each and are of the same class and are to be common shares."

3. The aforesaid Amendment was adopted on May 25, 2000, pursuant to a written statement and consent to corporate action executed by all of the shareholders and directors of the Corporation and therefore the number of votes in favor of the amendment was sufficient for approval.
