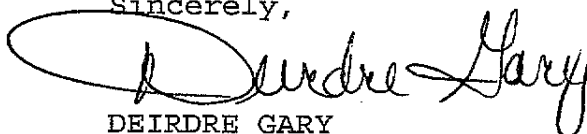

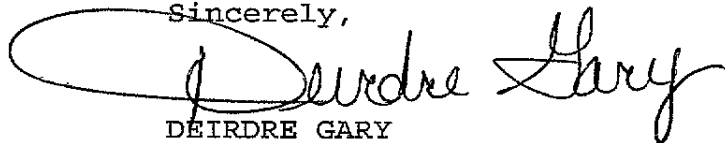

OF

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act hereby adopt the following Articles of Incorporation.

ARTICLE ONE
CORPORATE NAME

The name of the corporation is RELIABLE SOURCES, INC.

ARTICLE TWO
DURATION

The term of existence of the corporation is perpetual.

DEFINITIONS

The purpose for which the corporation is organized is: general investigations, process service and tenant screening.

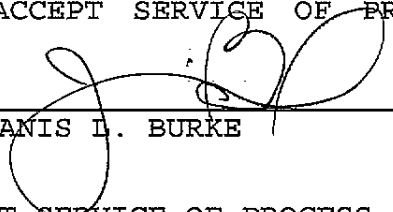

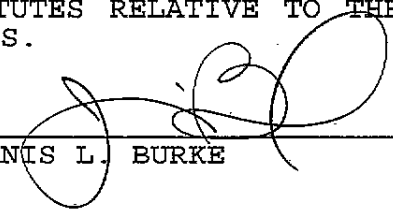

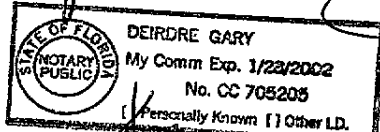
