OF

A. C. L. AUTO TRANSPORT, INC.

The undersigned incorporator hereby forms a corporation under Chapter 607 of the laws of the State of Florida.

ARTICLE I. NAME

The name of the corporation shall be:

A. C. L. AUTO TRANSPORT, INC.

The address of the principal office of this corporation shall be 2550 30th Avenue North, Saint Petersburg, Florida 33713, and the mailing address of the corporation shall be the same.

ARTICLE II. NATURE OF BUSINESS
