ARTICLES OF INCORPORATION

BY THESE ARTICLES OF INCORPORATION, the incorporator forms a corporation for profit under Florida law.

- 1. NAME. The name of this corporation is Promed, Incorporated.
- 2. <u>ADDRESS</u>. The street address and mailing address of the principal office of the corporation is:

- 3. TERM. The corporation shall exist perpetually.
- 4. <u>PURPOSE</u>. The purpose of the corporation is to transact any or all lawful businesses for which corporations may be incorporated under Chapter 607, Florida Statutes.
