ARTICLE I. NAME

The name of this corporation shall be New Age Consulting Group, Inc.

ARTICLE II. DURATION

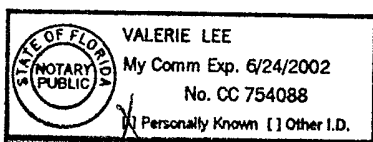



