Name

The name of the corporation is KEEN BATTLE MEAD PEO SOLUTIONS, Inc.



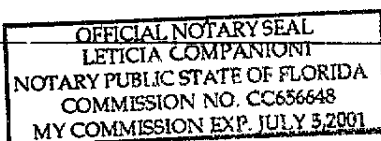


