**ARTICLES OF INCORPORATION
OF

I. NAME

The name of the corporation is Caxambas Development, Inc.

II. NATURE OF BUSINESS

The corporation may engage in any activity or business permitted under the laws of the United States and the laws of the State of Florida.


XI. AMENDMENTS

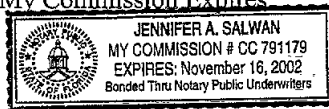
