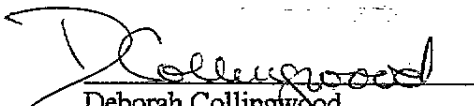

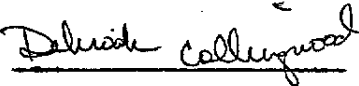

OF

ARTICLE I - NAME

The name of the Corporation is SALTY DOG HOME INSPECTIONS, INC.

ARTICLE XI - AMENDMENT

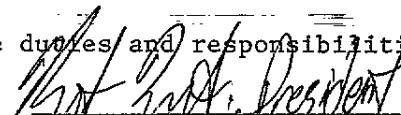

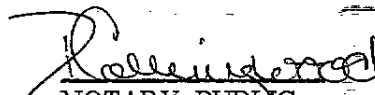
