The undersigned subscriber of these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation for profit under the laws of the State of Florida.

ARTICLE I: NAME AND MAILING ADDRESS

ARTICLE II. DURATION

This corporation shall have perpetual existence, commencing on the date of filing of these Articles.

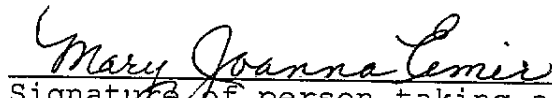

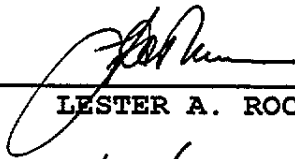
