

ARTICLES OF INCORPORATION

OF



The Plant Lady of Florida, Inc.

ARTICLE I - NAME

The name of this corporation is **The Plant Lady of Florida**, **Inc.**, with its principal office at 7475 SW 102 Street, Miami, Florida, 33156.

ARTICLE II -DURATION

This corporation shall have perpetual existence, unless dissolved in accordance with the laws of the State of Florida.

ARTICLE III - PURPOSE

ARTICLE IV - CAPITAL STOCK

The approval of the shareholders of this corporation to any plan of merger shall be required in every case, whether or not such approval is required by law.

ARTICLE XIII - INDEMNIFICATION

The corporation shall indemnify any officer or director, or any former officer or director, to the full extent permitted by law.

ARTICLE XIV - AMENDMENT

This corporation reserves the right to amend or repeal any provision contained in these Articles of incorporation, or any amendment hereto, and any right conferred upon the shareholders is subject to this reservation.
