

As a small business owner, it is little wonder why small corporation owners have little or no compassion for government. We receive none in return. Please see attached.


In early June, 2000, we realized that we had not filed the 2000 UBR. Your system did not advise us of this. On our own we realized that we had made a mistake and sent the fee of \$150.00 with an explanation. As stated in the attached letter, it was an oversight.

I am a state certified contractor. My company installs hurricane protection. We work in approximately 15 separate municipalities in Dade, Broward and Palm Beach Counties. You cannot imagine the paperwork involved maintaining and registering permitting approvals in this area. Not to mention the various city and county fees that we must pay to stay in business. It's really not so much the dollars as it is the paperwork. Can you possibly realize the amount of paperwork necessary to maintain a hurricane protection installation company in this area of Florida? We maintain very high standards, yet, one piece of paperwork fell in the cracks.

Contrary to the accepted practice in this industry we pull permits on every job, maintain workers compensation insurance on every installation crew, and maintain one million dollars of liability insurance. Compliance costs an incredible amount of money. Others in this industry do not pay this toll. Yet, at every turn, we are penalized for our compliance.

Included is the full payment of \$550.00 to reinstate the corporation, which includes the \$400.00 late fee. As a newly formed company we were hoping for some compassion, but maybe not.
