ARTICLE I

The name of the Corporation is Sokol Paralegal Services, Inc.

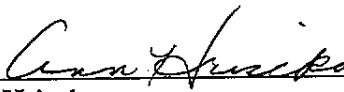
ARTICLE IX

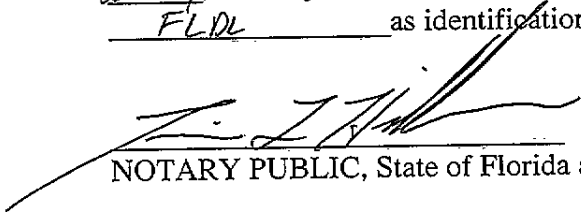

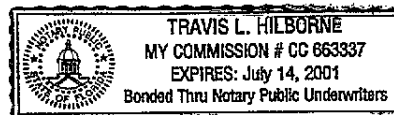

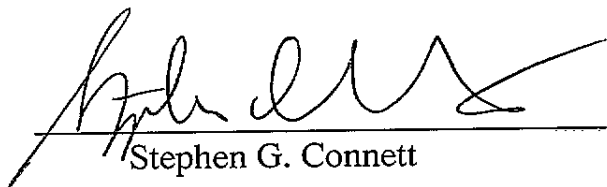
