

I. NAME

The name of the corporation is COMMISSION CONNECTION SALES CORPORATION.

#### X. AMENDMENTS

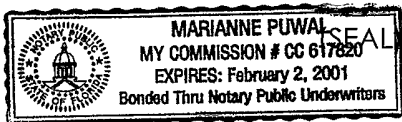




