ARTICLES OF INCORPORATION

OF

DINISION OF STATIONS SECRETARY CONTROL OF STATIONS OF

I. NAME

The name of the corporation is COMMISSION CONNECTION SALES CORPORATION.

II. TERM OF EXISTENCE

This corporation shall have perpetual existence.
