In compliance with the provisions of Chapter 607, Florida Statutes, the undersigned, for the purpose of forming a corporation, does hereby make, subscribe, acknowledge and file in the office of the Secretary of State of the State of Florida, as the Articles of Incorporation of ALL PRO CARPET CLEANERS, INC., a Florida corporation, the following, to wit:

Article I - Corporate Name

The name of the corporation is as follows:

This corporation shall exist perpetually unless dissolved in accordance with its Bylaws or pursuant to Florida law.
