**ARTICLES OF INCORPORATION**

The undersigned incorporator to these Articles of Incorporation hereby forms a corporation under the laws of the State of Florida as follows:

**ARTICLE I - NAME**

The name of this corporation is **SOUTHEAST CONSTRUCTION INSPECTION SERVICES, INC.**

**ARTICLE II - TERM OF EXISTENCE**

The date when corporate existence shall commence shall be February 1, 1999 and the corporation shall have perpetual existence thereafter.

**ARTICLE III - PURPOSES**
