ARTICLES OF INCORPORATION

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation:

ARTICLE I - NAME

The name of this Corporation is Brew This, Inc. The mailing address of the corporation is 9302 N.W. 24th Place, Sunrise, FL 33322.

ARTICLES II - PURPOSE
