In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the corporation ("Corporation") is Truck Stuff Inc.

ARTICLE II

The existence of the corporation shall begin when the Articles of Incorporation have been filed.

ARTICLE III

The address of the principal office of the Corporation is 117-B Towles Ave. Palatka, Florida 32177.

ARTICLE IV

The maximum number of shares this Corporation is authorized to issue is one hundred shares (100), all of which shall be Common Shares. All Common Shares shall be identical with each other in every respect and the holders thereof shall be entitled to one vote for each share upon all matters on which shareholders have the right to vote.

ARTICLE V

The initial street address of the Corporation's registered office is 117-B Towles Ave., Palatka, Florida 32177. The initial registered agent for the Corporation at that address is C. Ray Gore, Jr.

ARTICLE VI

ARTICLE VII

The name and address of the person signing these articles of incorporation is C. Ray Gore, Jr. whose address is 548B Cedar Creek Rd. Street, Palatka, Florida 32177.


ARTICLE VIII

ARTICLE IX


The corporation through its directors and shareholders reserve the right to file a Subchapter S election with the Internal Revenue Service.
