ARTICLE I - NAME

The name of this corporation is YOUNG MASONARY, INC.

ARTICLE II - PURPOSE

Juan Marulanda - President.


ARTICLE VIII - BEGINNING OF CORPORATE EXISTENCE

IN WITNESS WHEREOF, the undersigned incorporated have executed these Articles of incorporation, this January 19, 1999.



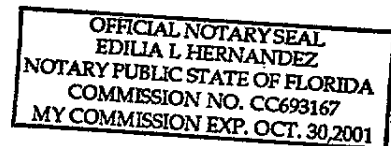
