### ARTICLE I. Name.

The name of the corporation shall be: Asset Inventory Management, Inc.

### ARTICLE II. Address

The principal place of business and mailing address of the corporation is:

### ARTICLE III. Registered Agent

The registered agent of the corporation is: Risa E. Reynolds.
