ARTICLES OF INCORPORATION OF Street Information Systems, Inc.

SECRETARY OF STATE TALLAHASSEE, FLORIDA

ARTICLE I NAME

The name of the corporation is Street Information Systems, Inc.

ARTICLE II DURATION

The corporate existence shall commence on the date of filing, and the duration of the corporation shall be perpetual.
