

# ARTICLES OF INCORPORATION

The undersigned, for the purpose of forming a corporation for profit under the laws of the State of Florida, hereby adopts the following Articles of Incorporation:

## ARTICLE I

# Name, Location and Mailing Address of Principal Office

## ARTICLE II

#### <u>Purpose</u>
