**ARTICLES OF INCORPORATION
OF
BLUE GOLD OF VALRICO, INC.**

ARTICLE I - NAME

The name of the corporation is **BLUE GOLD OF VALRICO, INC**

ARTICLE II - DURATION

As provided in Florida Statutes, Chapter 607, this corporation shall exist in perpetuity.

ARTICLE III - PURPOSE


ARTICLE XII - INDEMNIFICATION


